Why does this group exist? (1) Situation:

- Each LC exists as a legal entity in its country in accordance with the laws in force there. The club is also a regular member of LCI.
- Every member has membership in **this** club. By Constitution & ByLaws it is registered with LCI. (Lions Clubs International)
- Due to this constellation, the responsibility for collecting and processing the data lies with the Club's Board of Directors.
- The Club President is liable according to GDPR for the processing and also possible abuse.
- He can be made personally liable

Why does this group exist? (2) **Situation:**

- The Club has to have control over the data management.
- Each category of data must have a legal basis for processing.
- Each category must have a legal basis for transfer to the USA.
- GDPR requires the responsibility for all procedures from the club.

Online Solution for European Lions - Principles

- Target: Online Solution for Maintaining & Organising Lions Clubs / Districts / MDs
 - Control by the responsible in the country
 - Sharing of necessary data with LCI
- Multiple Districts and Districts (undistricted areas) work together
 - (no obligation for everyone)
- A Core Team to implement what the Extended Team has compiled
- Interested MDs/Ds start the project
- Costs to be shared by participating Countries on Basis of Number of Members
 - a financial contribution from international sources is appropriate
- Annual Reports to the Europa Forum

CODE OF CONDUCT




What is a GDPR Code of Conduct?

- With a CoC you set out the principles and the legal conditions for the Lionsclubs in the EEA.
- GDPR codes are voluntary accountability tools which set out specific data protection rules.
- It will describe what the most appropriate, legal and ethical set of behaviors is.
- The European Data Protection Board will prove our code.
